## PROBITY AUDITS AND ADVICE

To achieve integrity and transparency, councils must demonstrate an open and accountable procurement process that offers value for money.

While Council officers understand the necessity for conducting tendering processes in a fair, impartial and transparent manner it can be challenging to ensure an independent internal review of processes is undertaken.

## Tailored Probity Solutions

Regional Procurement will tailor Probity Advice Services to suit council's individual needs. Our Auditors will liaise with council stakeholders to determine the audit scope, criteria and procurement probity requirements.

Councils may choose, for example, to receive an unbiased commentary on stages that require specific compliance with legislation, including but not limited to the following:

- Distribution of identical tender information to potential tenderers
- Tender advertising
- Evaluation
- Culling of non-compliant tenderers
- Recommendation of successful tenderer/s
- Provision of feedback to unsuccessful tenderers

During the audit, the Regional Procurement Probity Auditor will liaise with nominated council staff and review sufficient and appropriate facts and documentary evidence relating to the Audit scope and criteria.

The Auditor will review procedures, tender documentation and evidence of tendering practices. They will objectively examine and evaluate information and processes and report on potential probity issues associated with the tender process, in accordance with Council's own Probity Plan.

They will measure the procurement process against relevant sections of the Local Government Act, Local Government (General) Regulation and Council's own policies and procedures.

The Probity Auditor will then use professional judgement to determine whether the evidence adequately supports the tender decision based on the pre-determined criteria and provides a clear and auditable trail of the tender process.

At the completion of the probity audit, Regional Procurement will provide a detailed and independent Audit Report that summarises observations, auditor recommendations, any areas of potential non-conformance and the Probity Auditor's determination on whether the tender process has met probity requirements.

## Fees

Regional Procurement Probity Advice and Audits are available at \$150 per hour including GST. A 'one-off' lump sum fee may be negotiated for specific Audit projects.
