# Letters of Agreement

Letters of Agreement (LoA's) are an informal arrangement between Regional Procurement and some Industry Partners. The LoA is NOT a formal contract, is not binding and does not in itself create a relationship between our member councils and the Industry Partner. It is intended to provide our member councils with access to a selection of suppliers that are willing to provide quotations for goods and services valued at less than \$150,000. Suppliers that have signed a LoA with Regional Procurement may be contacted to provide quotations to our member councils in addition to suppliers already known to Council. This competition should provide better outcomes for our valued member

Where such quotation amounts exceed the mandatory \$150,000 Local Government (General) Regulation threshold then a formal tender must be called by the member council unless the goods or services are being provided under an existing Regional Procurement contract already endorsed by Council.
